- The Town Highway Superintendent David Babcock, submitted a written report on activities for June 2016 and highlighted fuel usage, road side mowing, ditching, weed spraying, sluice pipe replacement.

Code Enforcement:

RESOLVED, that the Town Board of the Town of Westfield hereby determines that the Barcelona Hamlet Improvements project, funded by NYS Department of State Grant No. C007161, is a Type II action in accordance with 6 NYCRR Section 617.5(c)(2), (4), (5), and (6) because it involves the landscaping, maintenance, repair, and replacement of three existing parking lot facilities and streetscape improvements, including the installation of a kiosk, sidewalks, and lighting, and, as such, is not subject to further environmental review.

AUTHORIZING THE SUPERVISOR TO SIGN RURAL DEVELOPMENT DOCUMENTS RELATED TO SHOREHAVEN WATER SYSTEM IMPROVEMENTS

WHEREAS, the Town is pursuing a loan and grant from the United States Department of Agriculture/Rural Development to fund improvements to the Shorehaven water system; and

WHEREAS, if the Town receives a loan and grant package it may be necessary to perform various environmental studies and issue bonds for the project;

NOW, THEREFORE, BE IT RESOLVED:

- 1. The Supervisor is hereby authorized to execute all documents related to a Rural Development loan and grant package for the Shorehaven water system; and
- 2. The Supervisor is further authorized to issue a request for qualifications for the various professional services that may be required to complete the project, including, but not limited to, bond counsel and fiscal advisor.
