MAYOR/BOARD

MINUTES

The board made a motion by Trustee Holbrook, seconded by Trustee Santi and was carried unanimously to approve the minutes of August 21, 2017.

RESCIND RESOLUTION #24-2007

The board made a motion to rescind prior resolution #24-2007/Discharge of Firearms in the Village of Westfield by Trustee Cochran, seconded by Trustee Holbrook and was carried unanimously.

FUND RAISER SATURDAY, OCTOBER 28, 2017 @ 10:00 A.M.

The board made a motion to approve the use of Welch Field for "Run for Bereda" Fund Raiser by Trustee Holbrook, seconded by Trustee Santi and was carried unanimously. It was noted the route would be going up Spring Street, right on Wood St., up Walnut and then to Bliss and back to Welch Field.

BREAST CANCER AWARENESS WALK

The board made a motion by Trustee Holbrook, seconded by Trustee Santi and was carried unanimously to approve for a request by Absolut to have the "Walk Around the Block" for Breast Cancer Awareness on October 21, 2017. It will begin at the Absolut building on Cass St.; West on Main Street to Portage St. then back around again.

WACS SPIRIT WEEK

The board made a motion by Trustee Cochran, seconded by Trustee Santi and was carried unanimously to approve the request for a "Snake Dance to begin at Moore Park at 7:00 p.m. on Tuesday, September 26, 2017 and Homecoming Bonfire at Welch Field to follow.

WACS HOMECOMING PARADE

The board made a motion by Trustee Cochran, seconded by Trustee Santi and was carried unanimously to approve the WACS Annual Homecoming Parade for

Friday, September 29th, 2017 at 5:00 p.m. from Moore Park to WACS Track & Football Field. The route would be from Moore Park on Elm St. to McClurg; right on Portage St. down to Main and back to the School.

RESOLUTION #20-2017 EARLY RETIREMENT INCENTIVE

The following resolution was approved on a motion made by Trustee Holbrook, seconded by Trustee Cochran and was carried unanimously.

WHEREAS, the Village of Westfield Board of Trustees recognizes the need to create economic efficiencies within and amongst its departments Village wide in order to reinvest in key components of the Village's future plans and to better align with the State of New York's mandatory property tax cap program; and

WHEREAS, certain eligible Village of Westfield Employees may voluntarily elect to retire early by meeting the following criteria: Any full-time Village of Westfield Employee that is aged 55 years or older on or before February 28, 2018; and

WHEREAS, the Village of Westfield will offer those eligible employees as determined above, a one-time lump sum payment to each employee that opts into the program as follows based on the total number of employees who elect to take the early retirement benefit:

- 1-3 employees will each receive a \$15,000 lump sum payment; or
- 4-6 employees will each receive a \$20,000 lump sum payment; or
- 7 or more employees will each receive a \$25,000 lump sum payment

WHEREAS, those employees represented by the current collective bargaining agreement (union contract) between the IBEW Local 459 and the Village of Westfield (April 1, 2016 to May 31, 2019) who elect to take this early retirement incentive will receive all other final wages and benefits, and other bargained terms and conditions of employment as set forth in the said agreement as it relates to retirees of the Village. Examples include final wages, final payouts for their accrued unused, vacation and sick days, health insurance continuation coverage as fully detailed in Section 12.15.1a for retirees; and

WHEREAS, employees who are not covered by the union contract will receive the same post-retirement final wages and benefits as those employees covered by the Union Contract to include final payments for accrued unused sick and vacation time; health insurance continuation coverage as fully detailed below:

The Village of Westfield will pay 100% of the monthly health insurance premiums for medical continuation coverage for those full-time Village employees who decide to retire before age 65 subject to the following requirements:

- 1. The potential retiree is currently enrolled in the same medical insurance plan in effect for all other employees of the Village at the time of retirement.
- 2. The retiree will only receive this benefit until the age of 65.

- 3. The Village will pay only the monthly Single Rate for the retiree only. Dependent coverage will be 100% the financial responsibility of the retiree at all times.
- 4. Benefits will cease if the retiree expires before the age of 65.

5. In order to qualify for the retiree health continuation coverage described herein, an employee must retire as a current employee of the Village of Westfield and meet all New York State Retirement criteria to receive New York State Retirement benefits.

WHEREAS, employees opting to accept this early retirement offer must notify the Village Treasurer in writing by October 31, 2017. Employees must retire by February 28, 2018. Acceptances will be finalized after the consideration period has closed on October 31, 2017.

NOW THEREFORE BE IT RESOLVED, that the Village Board of Trustees does hereby enact an Early Retirement Incentive Program as stated herein.

BE IT FURTHER RESOLVED, that the Village of Westfield is not responsible for providing advice on Retirement for employees considering this program and all eligible employees are strongly encouraged to consult with their families and to contact the New York State Retirement System and any other trusted financial advisor, retirement planner or attorney.

CABLE TV COOPERATIVE AGREEMENT

WHEREAS, the existing cable television franchise agreement has already expired or is about to expire, and

WHEREAS, it is in the best interests of the community to renew said franchise, and WHEREAS, the Village of Mayville has offered to act as the lead agency in negotiating a cable television franchise renewal at no cost to the other municipalities, and

WHEREAS, it is believed that this shared service opportunity will benefit all of the municipalities involved, now therefore

BE IT RESOLVED that the Village of Westfield hereby agrees to have the Village of Mayville act as lead agency and negotiate a cable television franchise renewal with Spectrum (formerly Time Warner and that all for the individual franchise agreements will have the same terms and conditions contained therein

DISCUSS COMMUNITY WEBSITE DEVELOPMENT FUNDING

The board made a motion to approve taking \$4,000 out of Capital Reserve for Community Website Development Subject to Permissive Referendum by Trustee Santi, seconded by Trustee Holbrook and was carried unanimously.

He noted appreciation to have a board and Supervisors that worked with the Firemen and it could not have been a success without everyone's help.

SURPLUS RADIOS
