Resolution No. 49 of 2010

Adoption of LL#5-2010 / Amend the Animals Law

WHEREAS, said public hearing was duly held on December 1, 2010 at 7:25 p.m. at the said Eason Hall and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS, the Town Board hereby determines that the adoption of the local law is a Type II action for purposes of the State Environmental Quality Review Act, requiring no further review, and

WHEREAS, the Town Board of the Town of Westfield, after due deliberation, finds it in the best interest of the Town to adopt said Local Law,

NOW, THEREFORE BE IT REOLVED, that the Town Board of the Town of Westfield hereby adopts said Local Law as Local Law No. 5 of 2010, a copy of which is attached hereto and made a part hereof, and the Town Clerk hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Westfield, and to give due notice of the adoption of the Local Law to the Secretary of State.

Obtaining Beach Cleaning Machine
