RESOLVED, that the Town of Westfield hereby grants a license to David Spann over a parcel owned by the Town of Westfield adjacent to Chautauqua Creek, designated on the official tax map of Chautauqua County as Section 192.06, Block 1, Lot 9.2, to allow him to access the mouth of the creek with the equipment needed for ice removal and flood control purposes, in furtherance of the municipal interest of preventing flooding on the Town's property, neighboring properties, and nearby roads and highways.

James Herbert moved and Raymond Schuster seconded a motion that the Supervisor be directed to draw the necessary checks to cover the warrant as audited.
