David Spann moved and David Brown seconded a motion to waive the reading of the minutes inasmuch as all members received a copy thereof and that the minutes be approved. Unanimously carried.

- David Spann offered the following resolution and moved for its adoption:

Resolution No. 24 of 2015

Support to Amend Real Property Law in Relation to Conveyances of Paper Streets

WHEREAS, subdivision 2 of Section 291-a of the Real Property Law provides that in certain towns and villages in Chautauqua County any deed or instrument of conveyance which for the first time conveys an interest in a paper street shall have no force and effect and shall be declared null and void unless it is accompanied by a town board resolution authorizing the deed or conveyance, and

WHEREAS, the said subdivision applies currently within the towns of Chautauqua, North Harmony, Ellicott, Ellery, and Busti and the village of Celeron, and

WHEREAS, the Town of Westfield contains several subdivision allotments with paper streets and wishes to discourage the filing of deeds purporting to take title to such streets, and

WHEREAS, S.3422/A.6423 is an act to add the Town of Westfield, Chautauqua County, to Section 291-a of the Real Property Law, and

WHEREAS, this legislation will alleviate confusion regarding the ownership status of paper streets,

NOW, THEREFORE, BE IT RESOLVED, the Westfield Town Board unanimously supports New York Senate Bill S.3422 and New York Assembly Bill A.6423, and be it further

RESOLVED, that the Town Clerk be and is hereby authorized and directed to send a copy of this resolution to Hon. Andrew M. Cuomo, Governor of the State of New York; Hon. Catharine M. Young, New York State Senator, Hon. Andy Goodell, Member of the New York State Assembly; and to such other persons as the Town Clerk, in his discretion, may deem proper in order to effectuate the purpose of this resolution.

Authorization for Supervisor to Negotiate and Finalize a Lease with Plantrol in Welch Building

RESOLVED, that Supervisor Martha Bills is hereby authorized to negotiate the final terms and conditions of and execute with Plantrol Systems, Ltd., a lease agreement for approximately 2,000 square feet of office space in the Welch Building, 2 South Portage Street, Westfield, New York, at the rate of \$20,000 per year subject to Permissive Referendum.
