The Fire Department Report for May 2013 was received and placed on file.

Highway:

- The Town Highway Superintendent submitted a written report on activities for May 2013 and highlighted fuel usage, ditching, and roadside mowing.
- Raymond Schuster moved and David Spann seconded a motion to approve accepting a bid of \$15,000 + \$10,000 worth of gravel (total of \$25K) from Hardrock Gravel to sell the 2000 Sterling Truck. Unanimously approved.
- David Brown moved and David Spann seconded a motion to solicit for more bids (only received one) on the light posts recently removed from the Pier. Unanimously approved.

Code Enforcement:

- The Code Enforcement Officer submitted a written report highlighting that 14 permits were issued in the Town for May 2013 and also update the Board on the status of three homes in various phase of construction.

Barcelona Harbor: The upcoming Southtowns' Walleye Tournament will begin on June 8th with the Pier again designated as a Weigh Station. It was also noted that six new life rings have been put out.

WACS:

- WACS School Superintendent provided a presentation on the potential merger between Westfield and Brocton schools.
- He announced that the 'Straw Vote' to gage public opinion is set for June 18th, 2013.

Old Business:

 Supervisor Bills stated that the Barcelona Water Project continues to move forward with the CC Health Department finalizing their planning and an Engineer update being scheduled for the end of the month. She also stated that work continues at the Pier and in Barcelona using NYS DOS Streetscape grant funding. - Based on several concerns and requests, the Town will officially ask the NYS DOT to conduct a traffic study on W. Route 20.

New Business:

Negative Declaration

SUP Application for Limited Retail / Wholesale Business

WHEREAS, Richard & Debra Queer (hereinafter, the "Applicants") have submitted an application for a Special Use Permit to open a Limited Retail / Wholesale Business on property located at 7551 Bliss Road, on a parcel designated as Section 210.00, Block 1, Lot 50. The business would involve the packaging, shipping, and retail sale of fishing lures in an existing 30' x 30' building on the property, and

WHEREAS, the proposed use has been subject to environmental review pursuant to Article 8 of the New York State Environmental Conservation Law (State Environmental Quality Review Act), including the preparation and review of a short Environmental Assessment Form, and

WHEREAS, Part 617 of the implementing regulations pertaining to the State Environmental Quality Review Act requires this Board to determine and give notice of the environmental impact of the proposed use, and

WHEREAS, the Board has determined that the proposed use will not have a significant environmental impact,

NOW THEREFORE BE IT RESOLVED, that the Town Board hereby approves Part II of the Environmental Assessment Form as completed, issues the attached Notice of Determination of Non-Significance, also known as a Negative Declaration, for the proposed use, and authorizes the Supervisor to complete and sign the Environmental Assessment Form accordingly.

Resolution No. 29 of 2013

Issuance of Special Use Permit Limited Retail / Wholesale Business

WHEREAS, Richard & Debra Queer (hereinafter, the "Applicants") have submitted an application for a Special Use Permit (SUP) to open a Limited Retail / Wholesale Business on property located at 7551 Bliss Road, on a parcel designated as Section 210.00, Block 1, Lot 50. The business would involve the packaging, shipping, and retail sale of fishing lures in an existing 30' x 30' building on the property, and

WHEREAS, the issue of compliance with the State Environmental Quality Review Act has been addressed, and a Negative Declaration has been issued after examination of the record and public hearing, and

WHEREAS, the Town of Westfield Planning Board reviewed the application during a meeting held May 8, 2013 and recommended approval of the application, and

WHEREAS, the application was referred to the Chautauqua County Planning Department pursuant to Section 239m of the General Municipal Law, and it advised by letter dated May 28, 2013 that the application is a matter of local concern, and

WHEREAS, the Town Board has considered all the facts and papers before it, and has heard those wishing to be heard at a Public Hearing held June 5, 2013, and finds justification to approve the application subject to the qualifications hereinafter set out, now

THEREFORE, BE IT RESOLVED, that the application to open a Limited Retail / Wholesale Business on property located at 7551 Bliss Road, Westfield, be and hereby is authorized and approved subject to the conditions and requirements hereinafter set out:

- The Applicants shall undertake the project in accordance with the plans submitted to the Town with the
 application, except as hereinafter modified, and agree to be bound by the terms of the application and the
 conditions of this SUP.
- If operation of the business has not commenced within one year of the issuance of this SUP, this SUP shall become void and the Applicants shall be required to apply for a new SUP should they intend to continue the project.
- The terms, conditions, and requirements of this SUP bind and obligate the Applicants, their successors, and assigns. This SUP shall not be assigned or transferred, in whole or in part, without the prior written consent of the Town.
- 4. Any failure or omission on the part of the Applicants to carry out any condition or requirement herein or in accordance with the terms or requirements of any statute, local law, ordinance or regulation, may be deemed a violation of the Town of Westfield Zoning Law and unless corrected in not more than 10 days following the service of written notice of such violation upon the Applicants, may subject them to the penalties therein. Continued violations after written notice may result in revocation of this Special Use Permit.
- 5. This Special Use Permit shall become effective after the Applicants approve each and every provision hereof and agree to be bound by all of the terms herein contained in consideration of the granting of this Special Use Permit.

David Spann moved and James Herbert seconded a motion that the Supervisor be directed to draw the necessary checks to cover the warrant as audited.
