Supervisor Bills explained that the Public Hearing was being held to hear all persons in regard to an SUP application submitted by Robert Mazza to construct a Distillery & Winery on property owned by him at 8398 West Route 20 in Westfield. She noted that County Planning Department determined this to be a matter of local concern and the Town Planning Board recommended Town Board approval.

Mr. Mazza provided an overview of his current operations in New York and Pennsylvania. He then described the proposed Westfield project. He noted the facility would be a 5000 sq. ft. facility with a distillery business first. He emphasized that operations would meet all State & County Health standards for water use / septic and that ultimately the surrounding land would be beautified and used to grow products for the on-site business. He also discussed the different traffic patterns for customers and deliveries.

Several people in attendance commented:

- Fred Johnson expressed concern over the type of SUP issued (Commercial or Farm) and, if approved, the ability of the owner to expand the operation into a much larger manufacturing facility. He also raised concerns over waste water management considering the large amount of water needed to operate on a daily basis.
- Robert Ames also was also concerned with sewage in addition to increased traffic and speed limits. He also asked the Town to look into lowering the speed limit.
- Dawn & Greg Wozeneak expressed concern with truck traffic (i.e. deliveries) and the numbers / routing of trucks.
- Claire Quadri wanted to know what SEQR status is being used for this project. It was stated that this is being treated as an 'Unlisted' action.
- Several people in attendance (John Rawlinson, Aaron Resnick, Pete Noble, Max Baker, Dawn Betts, Carl Vilardo Jr., and Carl Vilardo III) expressed their support for the proposed business.

There being no further questions or comments, David Brown moved and David Spann seconded the motion that the public hearing be closed at 8:14pm. This was unanimously approved.

WHEREAS, Charles Groenendaal (hereinafter, the "Applicant") has submitted an application for a Special Use Permit to construct a dwelling within an existing building owned by him at 7868 Persons Road, Westfield, designated as tax map parcel Section 193.00, Block 1, Lot 45.2, and

WHEREAS, the proposed use has been subject to environmental review pursuant to Article 8 of the New York State Environmental Conservation Law (State Environmental Quality Review Act), including the preparation and review of a short Environmental Assessment Form, and

WHEREAS, Part 617 of the implementing regulations pertaining to the State Environmental Quality Review Act requires this Board to determine and give notice of the environmental impact of the proposed use, and

WHEREAS, the Board has determined that the proposed use will not have a significant environmental impact,

NOW THEREFORE BE IT RESOLVED, that the Town Board hereby approves Part II of the Environmental Assessment Form as completed, issues the attached Notice of Determination of Non-Significance, also known as a Negative Declaration, for the proposed use, and authorizes the Supervisor to complete and sign the Environmental Assessment Form accordingly.

Issuance of SUP (Construct Dwelling in an Existing Building / Groenendaal)

WHEREAS, Charles Groenendaal (hereinafter, the "Applicant") has submitted an application for a Special Use Permit to construct a dwelling within an existing building owned by him at 7868 Persons Road, Westfield, designated as tax map parcel Section 193.00, Block 1, Lot 45.2, and

WHEREAS, the Town of Westfield Planning Board reviewed the application during a meeting held June 20th, 2012 and has recommended approval of the application, and

WHEREAS, the Town board ("Board") has carefully considered the issue of compliance with the State Environmental Quality Review Act, and has issued a negative declaration after examination of the record and a public hearing, and

WHEREAS, the Board has considered all the facts and papers before it, and has heard those wishing to be heard at a public hearing held July 11, 2012, after publication of legal notice, and finds ample justification to approve the application subject to the qualifications hereinafter set forth,

NOW, THEREFORE, BE IT RESOLVED, that the application be and hereby is authorized and approved subject to the conditions and requirements hereinafter set out:

- 1. The SUP is intended to allow for a single family dwelling within the existing structure on site.
- 1. Within 30 days of signing and agreeing to the terms of this Special Use Permit, the applicant shall contact the Chautauqua County Soil & Water Conservation District to develop and implement mitigation measures to stop water runoff from applicant's property across Persons Road and onto neighboring property.
- 3. The Applicant shall undertake the dwelling project in accordance with the plans submitted to the Town with the application, and agrees to be bound by the terms of the application, the site plan, and the conditions of this permit.
- 4. This permit shall not be assigned or transferred, in whole or in part, without the prior written consent of the Town.
- 5. Any failure or omission on the part of the Applicant to carry out any condition or requirement herein or in accordance with the terms or requirements of any statute, local law, ordinance or regulation, may be deemed a violation of the Town of Westfield Zoning Law and unless corrected in not more than 10 days following the service of written notice of such violation upon the Applicant, may subject them to the penalties therein. Continued violations after written notice may result in revocation of this Special Use Permit.
- 6. This Special Use Permit shall become effective after the Applicant approves each and every provision hereof and agrees to be bound by all of the terms herein contained in consideration of the granting of this Special Use Permit.
