David Brown moved and David Spann seconded a motion to waive the reading of the minutes inasmuch as all members received a copy thereof and that the minutes be approved. Unanimously carried.

Highway:

- The Highway Superintendent submitted a written report on activities for July fuel usage, blacktopping, and mowing. Due to Proper is closing, went out for fuel bids which are due August 17th.

Code Enforcement:

- The Code Enforcement Officer submitted a report for July 2011 highlighting 14 Permits issued in the Town including a new single family residence on Parker Road. A new residential home on Sherman Road is near completion.

Barcelona Harbor:

- Jim Herbert briefed that issues discussed in the last Harbor Commission Meeting included the possibility of a shower and porta-pots for swimmers. He also noted that 30 August 2011 is the first Bass Master fishing tournament at the pier.

In Public Comment Claire Quadri asked about the status of the Wind Project DEIS and commented Board members gathering prior to a Town Board meeting.

an O & M Fund for East Main Road district are being worked.

Resolution No. 26 of 2011Adoption of Local Law 2-2011

WHEREAS, a resolution was duly adopted by the Town Board of the Town of Westfield for a public hearing to be held by said Board on August 3, 2011 at 7:25pm at the North Room of Eason Hall, 23 Elm Street, Westfield, New York to hear all interested parties on a proposed Local Law to extend the terms of office for the Town Supervisor, Town Clerk, and Town Superintendent of Highways from two to four years, subject to mandatory referendum, and

WHEREAS, notice of said public hearing was duly published in the Dunkirk Observer, and

WHEREAS, said public hearing was duly held on the said time and place all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS, the Town Board has determined that the adoption of the local law is a Type II action for purposes of the State Environmental Quality Review Act and no further environmental review is required, and

WHEREAS, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Westfield hereby adopts said local law as Local Law No. 2 of 2011, a copy of which is attached hereto and made a part hereof, and directs the Town Clerk and Town Attorney to prepare and submit to the Chautauqua County Board of Elections a ballot abstract for the general election to be held November 8, 2011, and if such law is approved by the voters at such election, the Town Clerk is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Westfield and to give due notice of the adoption of the Local Law to the Secretary of State.

Resolution No. 27 of 2011

Sponsor "Light the Lakes" Event

BE IT RESOLVED, that the Town Board Town of Westfield hereby authorizes the Supervisor to act on behalf of the Town Board as a sponsor of the 2011 *Light the Lakes* county-wide fireworks display. The Town's share of the expenses is not to exceed \$2500. The Town Board waives the \$50 permit fee for the display and will allow the Westfield / Barcelona Chamber of Commerce to use the pier on the afternoon and evening of September 4th, 2011
