50kw Generator / American Tower Site (Douglas Road)

WHEREAS, American Tower (hereinafter, the "Applicant") has submitted an application to amend their existing Special Use Permit to install a 50kw Generator on a 7'x14' concrete pad within an existing telecommunications facility on a parcel of land located on Douglas Road, Westfield, designated as tax map parcel Section 242.00, Block 2, Lot 7.1 and

WHEREAS, the proposed use has been subject to environmental review pursuant to Article 8 of the New York State Environmental Conservation Law (State Environmental Quality Review Act), including the preparation and review of a short Environmental Assessment Form, and

WHEREAS, Part 617 of the implementing regulations pertaining to the State Environmental Quality Review Act requires this Board to determine and give notice of the environmental impact of the proposed use, and

WHEREAS, the Board has determined that the proposed use will not have a significant environmental impact,

NOW THEREFORE BE IT RESOLVED, that the Town Board hereby approves Part II of the Environmental Assessment Form as completed, issues the attached Notice of Determination of Non-Significance, also known as a Negative Declaration, for the proposed use, and authorizes the Supervisor to complete and sign the Environmental Assessment Form accordingly.

Resolution #47 of 2012 Issuance of Amendment to SUP 50kw Generator / American Tower (Douglas Road)

WHEREAS, American Tower (hereinafter, the "Applicant") has submitted an application to amend their existing Special Use Permit to install a 50kw Generator on a 7'x14' concrete pad within an existing telecommunications facility on a parcel of land located on Douglas Road, Westfield, designated as tax map parcel Section 242.00, Block 2, Lot 7.1 and

WHEREAS, the issue of compliance with the State Environmental Quality Review Act has been addressed, and a Negative Declaration has been issued after examination of the record and public hearing, and

WHEREAS, the Town of Westfield Planning Board reviewed the application during a meeting held September 19, 2012 and recommended approval of the application, and

WHEREAS, the application was referred to the Chautauqua County Planning Department pursuant to Section 239-m of the General Municipal Law, and it advised by letter dated September 24, 2012 that the application is a matter of local concern, and

WHEREAS, the Town Board has considered all the facts and papers before it, and has heard those wishing to be heard at a public hearing held October 3, 2012, and finds justification to approve the application subject to the qualifications hereinafter set out, now

THEREFORE, BE IT RESOLVED, that the application to install a 50kw Generator on a 7'x14' concrete pad within an existing telecommunications facility on a parcel of land located on Douglas Road, Westfield,, be and hereby is authorized and approved subject to the conditions and requirements hereinafter set out:

- 1. The Applicant shall undertake the project in accordance with the plans submitted to the Town with the amendment application, except as hereinafter modified, and agree to be bound by the terms of the application and the conditions of this permit.
- 2. If operation of the Facility has not commenced within one year of the issuance of this permit, this Amendment to the existing Special Use Permit shall become void and the Applicant shall be required to apply for a new amendment should it intend to continue the project.
- 3. The terms, conditions, and requirements of this permit bind and obligate the Applicant, their successors, and assigns. This amendment shall not be assigned or transferred, in whole or in part, without the prior written consent of the Town.

- 4. Any failure or omission on the part of the Applicant to carry out any condition or requirement herein or in accordance with the terms or requirements of any statute, local law, ordinance or regulation, may be deemed a violation of the Town of Westfield Zoning Law and unless corrected in not more than 10 days following the service of written notice of such violation upon the Applicant, may subject them to the penalties therein. Continued violations after written notice may result in revocation of this Amendment to their Special Use Permit.
- 5. This amendment to the existing Special Use Permit shall become effective after the Applicant approves each and every provision hereof and agree to be bound by all of the terms herein contained in consideration of the granting of this Special Use Permit.

Resolution #48 of 2012 Standardized Equipment

WHEREAS, the Highway Department of the Town of Westfield, Chautauqua County, New York, presently owns 5 pieces of snow plow equipment all manufactured under the Everest brand and has on hand a supply of spare parts therefore; and

WHEREAS, to purchase a different brand of snow plow equipment would be inefficient and uneconomical since alternate brands and additional supplies of spare parts would have to be purchased which would not be interchangeable with the ones already on hand, and

WHEREAS, for other reasons such as handling and operation of the equipment and attaching snow plows and other implements, it is desirable to purchase an additional truck to be used for snow-plowing purposes and that the snow plow equipment used on that truck be of the same make as that presently owned by the Town,

NOW, THEREFORE, BE IT RESOLVED, that for reasons of efficiency and economy and pursuant to the authority conferred by Subdivision 5 of section 103 of the General Municipal Law, it is determined by this Board that there is a need for standardization in the purchase of equipment manufactured under the Everest brand for the Town Highway Department, and

BE IT FURTHER RESOLVED, that the Town Highway Superintendent be and hereby is authorized to contract for the purchase of additional items manufactured under the Everest brand, as needed, pursuant to the Procurement Policy previously adopted by the Town Board.
