Resolution No. 40 of 2013 Negative Declaration Local Law 5-2013

WHEREAS, the Town of Westfield has proposed Local Law No. 5 of 2013 to establish a Lakeside Cottage Overlay District within the existing Residential-Lakeside District in order to protect and preserve those traditional "cottage park" areas that are converting from their traditional seasonal use to full-time residential use and are more densely populated than the rest of the district, and

WHEREAS, the proposed local law has been subject to environmental review pursuant to Article 8 of the New York State Environmental Conservation Law (State Environmental Quality Review Act), including the preparation and review of a long Environmental Assessment Form, and

WHEREAS, Part 617 of the implementing regulations pertaining to the State Environmental Quality Review Act requires this Board to determine and give notice of the environmental impact of the proposed local law, and

WHEREAS, the Board has determined that the proposed local law will not have a significant environmental impact,

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby issues a Notice of Determination of Non-Significance, also known as a Negative Declaration, for the proposed Local Law No. 5 of 2013.

WHEREAS, a resolution was duly adopted by the Town Board of the Town of Westfield for a public hearing to be held by said Board on October 2nd, 2013 at 7:15pm at the North Room, Eason Hall, 23 Elm Street, Westfield, New York 14787, to hear all interested parties on a proposed Local Law to protect and preserve those traditional "cottage park" areas that are converting from their traditional seasonal use to full-time residential use and are more densely populated than the rest of the district, and

WHEREAS, notice of said public hearing was duly published in the Westfield Republican, and

WHEREAS, said public hearing was duly held on October 2nd, 2013 at 7:15pm at the said Eason Hall and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS, on September 20th, 2013 the County Planning Department, pursuant to Section 239-m of the General Municipal Law, advised that the proposed Local Law was of local option, and

WHEREAS, the Town Board has determined that the adoption of the local law is a Type I action for purposes of the State Environmental Quality Review Act, has prepared a full Environmental Assessment Form, and has duly adopted a Negative Declaration finding that the proposed Local Law will not have significant adverse environmental impacts,

WHEREAS, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law,

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Westfield hereby adopts said local law as Local Law No. 5 of 2013, a copy of which is attached hereto and made a part hereof, and directs the Town

Clerk to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Westfield and to give due notice of the adoption of the Local Law to the Secretary of State.
