Carol Rasmussen, Project Manager of the Chautauqua Region Economic Development Corporation (CREDC) introduced herself as well as gave an overview of the Community Development Block Grant.

The public hearing is held pursuant to the requirements of the Community Development Block Grant program. The purpose of the Public Hearing is to update the public on grant funding awarded to 3811 Holdings, Inc. dba Ghostfish Brewing Company East and are required to compile a list of people attending the hearing. All members of the public who are joining to sign in, and please identify themselves if they wish to speak.

The CDBG program provides grants to municipalities in order to ensure safe, decent, and affordable housing; assist businesses and activities that will create and retain employment opportunities; and provide improved public facilities and services. The OCR generally only funds projects or activities where at least 51% of the activity beneficiaries are low- to moderate-income persons (LMI). A low- or moderate-income person is one who is a member of a family whose income is at or below 80% of the area median income established by the U.S. Department of Housing and Urban Development.

In September 2021, the Town of Westfield authorized an application to go forward with the Office of Community Renewal to finance a project for 3811 Holdings, Inc. dba Ghostfish Brewing Company East to utilize grant funding. This amount was not to exceed \$103,000.00, including administrative fees.

The Chautauqua Region Economic Development Corporation, through an agreement with the Town of Westfield provided the OCR grant funds through CREDC. The deferred loan in the amount of \$89,000 was directly given to Ghostfish Brewery East to assist in financing a portion of the machinery and equipment and working capital costs associated with a project within the Town of Westfield.

The funding is complete, and this second public hearing is a requirement during the implementation phase of the project, or activity that the CDBG funds are supporting.

The company has met the targets for private investment. Ghostfish Brewing Company East have created 6 new jobs, of which are low-to-moderate income individuals. Two of the six have relocated from out-of-state.

The canning line is now in-house and should be operational by September 2024. Once operational, the company will continue to hire.

The company has refurbished 5,000 SF of a banded warehouse and turned it into an operating brewery, which retails to 10 states. Plenty of room for growth.

Any person wishing to make comments regarding community needs or the proposed project is now invited to do so. Please state your name prior to making your comments. No comments were received.
