WHEREAS, the Chautauqua County Multi-Jurisdictional Hazard Mitigation Plan, dated June 7, 2024, identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the Town of Westfield from the impacts of future hazards and disasters; and

WHEREAS, adoption by the Town Board of the Town of Westfield demonstrates their commitment to hazard mitigation and achieving the goals outlined in the Chautauqua County Multi-Jurisdictional Hazard Mitigation Plan, dated June 7, 2024.

Section 1. **WHEREAS**, wind turbines in Lake Erie would be detrimental to the area in several ways, including (a) the release of pollutants into the waters of Lake Erie, which is a source of drinking water for many of our neighbors, (b) the potential negative impact on the commercial and recreational fishing industries based in Barcelona Harbor; and (c) the aesthetic impacts along our picturesque shoreline, which attracts significant tourism revenue,
