The regular meeting of the Town Board was called to order at 7:30pm in Eason Hall, 23 Elm Street, Westfield, NY, with the following members and guests present:

Pledge of Allegiance

Councilman Will Northrop made the motion to waive the reading of the December 5th and December 13th minutes inasmuch as all members received a copy thereof and the minutes be accepted. Councilman David Spann seconded the motion. The motion was carried unanimously.

Reports:

The Town Clerk's report together with a check in the amount of \$1,896.21 representing fees for the month of December 2018 was turned over to Supervisor Bills. A check for \$22.50 representing fees for the month of December to NYS Department of Health, Marriage Licenses and a check in the amount of \$15.00 was turned over to NYS Department of Agriculture and Markets and NYS Decals in the amount of \$42.51 will be withdrawn on the 15th. A check in the amount of \$790.00 representing fees for the month of December was turned over to the Village of Westfield for Registrar of Vital Statistics fees collected.

Supervisor Bills presented the monthly report on the Town's finances for the month of November. The report is always available in the Supervisors office. Everyone is welcome to view. All Board members have received a copy of the report for November 2018 and is accepted as submitted.

The Dog Warden's report for December 2018 was received and placed on file. The Fire Department Report for November and December 2018 was received and placed on file. The Town Court report for December 2018 was received and placed on file. The WPD report for December 2018 was received and placed on file.

Highway:

- The Town Highway Superintendent discussed plowing roads, fuel and gas usages and working on a boat launch at the Town Shop.
- Highway Superintendent asked the board to purchase a ½ ton cab truck, a 2018 regular cab ½ ton truck estimating \$32,061.00 or a 2019 Crew cab ½ ton truck at \$34,475.00. A discussion ensued. Councilman David Spann made the motion to allow the purchase of the 2019 Crew cab ½ ton truck estimating \$34,475.00. Councilman James Herbert seconded the motion and carried unanimously.
- The Town of Westfield Highway Department 2018 jobs completed report for the Town of Westfield was received and placed on file.

Code Enforcement:

- The Code Enforcement Officer submitted a written report for December 2018 was received and placed on file. The report also included an annual report for 2018.
- A Special Use Permit has been received for a Tractor Supply Company on Nicholas Ave. *Councilman Will Northrop made the motion to refer the Special Use Permit to the Town Planning Board and County Planning Board. Councilman, James Herbert seconded the motion and carried unanimously.*

Barcelona Harbor:

- Pier operations are closed for the season
- Chautauqua County has been awarded a grant through the CFA for several handicapped accessible kayak launches. Barcelona is one of the locations however, no further information has been received at this time.

Public Comments:

- Two Bliss Street residents asked the board to move forward with a study adding a waterline extension to Bliss. The Town Supervisor received a letter from the Bliss St residents, 8 out of the 11 property owners are interested in moving forward. Supervisor Bills discussed the process. The board will have to look to see if grant funding is available and if this is feasibly possible for the property owners and the Town.

Project updates: Supervisor Bills made the following announcements:

- Supervisor Martha Bills made the motion to have the Annual Audit of Books on Tuesday, Jan 22, 2018 at 3:00pm. The audit is required by the State every year. Seconded by Councilman David Spann and carried unanimously.
- Supervisor Bills will be attending a meeting in Buffalo on January 11th regarding the grant funding for the Welch building.
- Shorehaven water project is in the process of being closed out.
- Welch Trail project, the Town, Village and County will meet regarding the grant.
- East Lake Rd water project, no additional information is available at this time with the government shut down.
- Town and County Tax bills were printed in error by the Chautauqua County Department of Real Property tax. The Town Bookkeeper found the error and notified the County. Tax payers were mailed a white tax bill which was the incorrect bill. The County had a program error. A new yellow tax bill was mailed out to property owners to be paid. The Town and the County are working together to resolve the error in a timely manner. The Town of Westfield was not the only Town that had an error with their tax bills at least 6 municipalities had printing errors with their 2019 Town and County tax bill.

1. The oiling and stoning within the budget allotment of portions of the following roads: Jones road (1.42 mile) Light road (.6 mile) Taylor road (.58 mile) Walker road (1.53 mile) Felton road (.63 mile) Total miles = 4.76

2. Should the Town receive funds under the Consolidated Highway Improvement Project System (CHIPS),

Funds estimated for 2019 \$128036.00 = moneys to be used on finishing re-blacktopping Ogden road / Finish re-black topping Putnam road / Jamestown street

BE IT FURTHER RESOLVED, that no fewer than three members of the Town Board and the Highway Superintendent shall execute a certified copy of this resolution in duplicate, and said certified copy, so

signed, shall constitute written agreement between the parties once it shall have been approved by the County Superintendent of Highways.
