Carol Rasmussen the Business Development Manager of the Chautauqua Region Economic Development Corporation introduced herself as well as gave an overview of the Community Development Block Grant.

The public hearing is held pursuant to the requirements of the Community Development Block Grant program including a list of people attending the hearing. All members of the public joining the hearing were asked to identify themselves by signing in.

The Community Development Block Grant (CDBG) Program is a federally funded program authorized by Title 1 of the Housing and Community Development Act of 1974 and administered by the United States Department of Housing and Urban Development (HUD). Funds are provided directly by HUD to large municipalities (generally over 50,000 in population for cities, villages, and towns and 200,000 for counties) through the Formula Entitlement program. For all other municipalities, the New York State Office of Community Renewal (OCR) is New York State's designated agency for distributing CDBG funds through the Small Cities program. The CDBG program provides grants to municipalities in order to ensure safe, decent, and affordable housing; assist businesses and activities that will create and retain employment opportunities; and provide improved public facilities and services. The OCR generally only funds projects or activities where at least 51% of the activity beneficiaries are low- to moderate-income persons (LMI). A low- or moderate-income person is one who is a member of a family whose income is at or below 80% of the area median income established by the U.S. Department of Housing and Urban Development.

Municipalities intending to apply for CDBG funding are required to hold a public hearing prior to submitting the application. The hearing is for the purpose of (i) soliciting public input regarding community development and housing needs in the municipality; and (ii) soliciting public comment regarding any specific activities proposed for submission.

If funding is awarded, a second public hearing will be required during the implementation phase of the project or activity the CDBG funds are supporting.

The Chautauqua Region Economic Development Corporation has asked the Town of Westfield to apply for a grant in an estimated amount up to \$150,000 from the OCR that will be provided as a grant to CREDC, which will use the funds to provide a loan or loans to Ghostfish Brewing Company East LLC to assist in financing a portion of the furnishings, fixtures and equipment and working capital costs associated with a project within the Town. Ghostfish Brewing Company East LLC is proposing to make certain building renovations, acquire and install furnishings, fixtures and equipment, and incur working capital expenses in connection with its establishment of a brewery operation in the Lake Erie Grape Discovery Center in the Town of Westfield, New York. The total project cost is expected to be approximately \$545,000. The project is expected to create up to an estimated 10 full-time equivalent jobs, the majority of which will be made available to low- and moderate- income individuals.

Any person wishing to make comments regarding community needs or the proposed project were invited to do so. No comments were received.

Proof of publication of the public hearing was posted by the Town Clerk in the newspaper, Town sign board and posted outside of the Town Clerk's window as well as the Town website.

At 7:30pm Carol Rasmussen Business Development Manager of the Chautauqua Region Economic Development Corporation closed the public hearing.

FURTHER RESOLVED, that this Board approves the following Grievance Procedure under the Americans with Disabilities Act:

GRIEVANCE PROCEDURE UNDER THE AMERICANS WITH DISABILITIES ACT

This Grievance Procedure is established to meet the requirements of the Americans with Disabilities Act of 1990 (ADA). It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in the provision of services, activities, programs, or benefits by the Town of Westfield. Employment related complaints of disability discrimination are covered elsewhere, in policies available from the human resources office of the Town of Westfield.

The complaint should be in writing and contain information about the alleged discrimination such as name, address, phone number of complainant and location, date and description of the problem. No particular format of the complaint is required. Alternative means of filing complaints, such as personal interviews or a tape recording of the complaint, will be made available for persons with disabilities upon request.

The complaint should be submitted in writing by the grievant and/or his/her designee as soon as possible but no later than 60 calendar days after the alleged violation to:

Within 15 calendar days after receipt of the complaint, the ADA Coordinator or his/her designee will meet with the complainant to discuss the complaint and the possible resolutions. Within 15 calendar days of the meeting, the ADA Coordinator or his/her designee will respond in writing, and where appropriate, in a format accessible to the complainant, such as large print, Braille, or audio tape. The response will explain the position of the Town of Westfield and offer options for substantive resolution of the complaint.

If the response by the ADA Coordinator or his/her designee does not satisfactorily resolve the issue, the complainant and or his/her designee may appeal the decision within 15 calendar days after receipt of the response to the agency head or his/her designee.

Within 15 calendar days after receipt of the appeal, the agency head or his/her designee will respond in writing, and, where appropriate, in a format accessible to the complainant, with the agency's final resolution of the complaint, or indicating that the matter has been returned to the ADA Coordinator for further action. If further response is indicated, the complainant will be contacted within 15 calendar days.

All written complaints received by the ADA Coordinator or his/her designee, appeals to the agency head or his/her designee, and responses from these two offices will be retained by the Town of Westfield for at least three (3) years.

basis to the benefited properties within the newly-defined East Route 5 Water Benefit District No. 2, and

WHEREAS, the proposed method to be employed for financing such improvement is an estimated \$1,806,000 grant from the U.S. Department of Agriculture and the issuance of serial bonds for the balance, and

WHEREAS, the cost of the improvements to the typical one- or two- family, full-time resident home in the benefited area will be \$968 per year, which figure includes \$529 per year for water costs and \$25 per year for North Town Water District costs; and
