- Land owners in the agricultural districts are receiving notices for a public hearing for proposed modifications to the district. All districts are currently subject to eight-year review and consolidation administered by Chautauqua County.

The Town Clerk's report for February was received and accepted and placed on file. A check in the amount of \$1,834.26 representing fees for the month of February 2022 was turned over to the Town Supervisor. A check for \$22.50 representing fees for the month of February to NYS Department of Health, Marriage Licenses and a check in the amount of \$26.00 was turned over to NYS Department of Agriculture and Markets and NYS Decals in the amount of \$47.24 will be withdrawn on the 13th of March.

Barcelona Harbor:

Closed for the Season.

Discussed the entrance to the harbor. Due to the storm damage, emergency boats, charter boats, fishing boats etc. cannot enter or leave the entrance. The Coast Guard is aware of the situation. However, they have not yet posted the information for boaters and boaters are concerned. The Town Supervisor continues to speak with congressional leaders, county representatives along with the Army Corp of Engineers regarding the issue, solutions and paperwork. The Town cannot proceed without getting assistance from the Army Corp of Engineers, DEC, for permitting and funding. This is a Federal Channel, federally owned. Discussed the size and cost of the project. Discussed community involvement of individually writing congressional representatives. Business owners, presented concerns. Tournaments, local business and community involvement were discussed.

Supervisor Bills, Highway Superintendent and Town Board members thanked the concerned citizens for their comments and suggestions as everyone wants to be able to use the harbor. At this time, we have to wait to hear about the federal budget and better weather to get out there to see what can be done. Further information will be forthcoming.
