POLES PURCHASE

The board made a motion by Trustee Freifeld, seconded by Trustee Maras and was carried unanimously to approve for the purchase of poles to Stella Jones in the amount of \$18,538.00. Other quotes received as follows: Matagorda Island Inc.

@ \$18,556.00 and American Timber & Steel @ \$17,550.00.

It was further explained that Stella Jones was the 2nd lowest bidder, and the most per pole, but they are the only ones who don't have estimated freight charges, so we can't be sure of the final price. Also, with the other 2, we must unload the truck, which ties up 3 or 4 guys plus our digger truck for 2-3 hours or so. The self-unloader that Stella Jones uses has them unloaded and gone in about 30 min. Plus the price is down some, back to below the \$20,000 mark for a load of poles where we had to request sealed bids.
